### **Safe handling**

Store in accordance with good manufacturing practices, in cool place and far from direct sunlight. Protect from humidity and keep away from water.

## **Personal protection**

**Eye/Face Protection:** Use safety glasses (with side shields). Safety glasses (with side shields) should be consistent with EN 166 or equivalent. If there is a potential for exposure to particles which could cause eye discomfort, wear chemical goggles.

Chemical goggles should be consistent with EN 166 or equivalent. If exposure causes eye discomfort, use a full-face respirator.
